

Report to ISO TC46/SC4 – meeting June 2015

ISIL Registration Authority (ISO 15511)

April 8, 2015

Danish Agency for Culture is Registration Authority for ISO 15511 *Information and documentation - International Standard Identifier for Libraries and Related Organizations (ISIL)*.

The ISIL Registration Authority (RA) maintains the list of agencies and advice possible future agencies.

The purpose of ISIL is to define and promote the use of a set of standard identifiers for the unique identification of libraries and related organizations with a minimum impact on already existing systems. A national or institutional agency assigns the specific identifier for a library or an organization. Libraries and other institutions have to contact an agency to get an ISIL standard identifier.

An ISIL identifies an organization, i.e. a library or a related organization, or one of its subordinate units, which is responsible for an action or service in a bibliographic environment (e.g. creation of machine-readable information). It can be used to identify the originator or holder of a resource (e.g. library material).

The ISIL is intended for use by libraries, archives, museums, and agencies doing business with these, such as suppliers and publishers. An ISIL identifies at a global level an organization, or one of its subordinate units, throughout its life. The first part of an ISIL is the two letter country code or a non-country code (one, three, or four characters in length).
